PURCHASE AGREEMENT, TERMS AND CONDITIONS

This agreement, entered into this _____ day of _____, 20____, by and between MIAMI UNIFORMS, INC. and / or FASHION SCRUBS, INC., hereinafter referred to as "Seller" and _____, hereinafter referred to as "Buyer."

The parties agree as follows:

1. **SALE:** The Seller agrees to sell to the Buyer and the Buyer agrees to buy from the Seller, subject to the terms and conditions set forth in this agreement, the items which will be ordered from time to time by Buyer, not to exceed \$_____.
2. **TERMS:** Seller will invoice all sales when shipped and Buyer agrees to pay the net invoice amount within 30 days, unless otherwise agreed to in writing, less any shortages or returns pursuant to the paragraphs below. (These terms are based on Buyers credit worthiness.)
3. **WARRANTY:** Seller warrants that all goods shipped are free from factory defects, however garments are not flame retardant and are not meant to be worn where there is risk of fire.
4. **SHORTAGES:** Any report of shortages or damage to goods must be reported in writing to Seller by fax at 305-234-0332 within 72 hours of receipt, in order to be credited to Buyers account. Buyer shall not accept torn, wet or partially open boxes from shipper, if it does, then Buyer becomes responsible for merchandise in the condition in which it is received.
5. **RETURNS:** All returns must be in their original re-sellable condition and are subject to a 20% restocking charge. Only those returns authorized by Seller with a Return Authorization Number (RA#) will be accepted by Seller and credited to Buyers account.
6. **LATE PAYMENTS:** All accounts that are not current within the terms provided in paragraph 2 above, shall be charged interest at the rate of one and one-half percent (1.5%) per month and no additional orders will be shipped. Any account that is more than thirty (30) days past the term shall have all pending orders that are in production cancelled.
7. **ATTORNEYS FEES & COST:** If any litigation should arise out of this agreement, the prevailing party in such litigation shall be entitled to recover reasonable Attorneys' fees and costs at both the trial and appellate levels.
8. **JURISDICTION & VENUE:** This contract shall be governed under the laws of the State of Florida. Jurisdiction for any dispute arising from this contract shall be the Courts of Miami-Dade County, Florida.
9. **PERSONAL GUARANTEE:** The undersigned authorized signor for Buyer shall personally guarantee payment to Seller for all goods received.
10. **SIGNATURES:** Signatures sent via facsimile or other electronic means are acceptable for all purposes, and will be binding upon the person signing.
